: PROHIBITION ON THE ELECTION AND APPOINTMENT OF ELECTIVE OFFICIALS AS

OFFICERS OF THE COOPERATIVE

"Par. (2) of Art. 27 of the Philippine Cooperative Code of 2008 provides:

"Art. 27. Government Officers and Employees.

- (1) Xxx
- (2) All elective officials of the Government shall be ineligible to become officers and directors of cooperatives: *Provided*, That the disqualification does not extend to a party list representative being an officer of a cooperative he or she represents; and
- (3) Xxx."

Par. (11) of Art. 5 of the Philippine Cooperative Code of 2008 provides:

Art. 5. Definition of Terms.

The following terms shall mean:

Xxx

(11) Officers of the Cooperatives shall include the members of the board of directors, members of the different committees created by the general assembly, general manager or chief executive officer, secretary, treasurer and members holding other positions as may be provided for in their by-laws;

XXX

Under the afore quoted provisions it is **prohibited to appoint elective officials as officers of the cooperatives** which include among others the following:

- (1) Members of the Board of the Directors;
- (2) Members of the different committee created by the general assembly;
- (3) General Manager or the Chief Executive Officer;
- (4) Secretary;
- (5) Treasurer; and
- (6) Members holding other positions as may be provided for the by-laws of the cooperative.
